CIRCULAR ON COVID-19

On 11 March 2020, the World Health Organization raised the level of alert prompted by the COVID-19 virus from

public health emergency to international pandemic.

In accordance with articles 29.1, 32 and 33 of the "Puerto José Banús" Port Service and Policing Regulations, and

with article 45 of the Act 21/2007, of 18 December, on the Legal and Economic Framework of the Ports of Andalusia, article 7.1. of the Act 14/2014, on 24 July, on Maritime Navigation, in line with the Recommendations of

the Ordinance issued by the Mayor of Marbella on 14 March 2020, and given that its international propagation

could entail a risk to public health in the countries in question, under the auspices of the recently activated

Emergency Land Use Plan of Andalusia, the conventions of the International Maritime Organization with regard to

maritime security and protection and port facilities, and in fulfilment of the Royal Decree 465/2020. of 14 March,

which declares the state of alarm for the purposes of handling the crisis situation prompted by COVID-19

and having notified the Málaga Maritime Authority and the Andalusia Public Ports Agency,

YOU ARE HEREBY INFORMED:

First.- For the period of fifteen (15) calendar days established in the Royal Decree 463/2020, and any

extensions thereof, opening to the public of the port facilities (Port service area) is suspended.

Second.- For the period of fifteen (15) calendar days established in the Royal Decree 463/2020, and any

extensions thereof, authorisation for the movement of vessels in the internal waters of the Port is

suspended.

During the period of suspension, <u>the jetties will remain closed to the public</u>: Those responsible for or workers on the vessels must maintain the jetties closed on entering or leaving them to attend to urgent and pressing needs

caused by force majeure or an emergency.

Third.- To meet the urgent and pressing needs of the public port service in relation to the protection of port

facilities, maritime navigational and vessel safety (offering haven due to storm or breakdown, navigational signals, marine rescue, return of vessels, etc., **a duty service is maintained.**

Fourth.- Catering and restaurant services are likewise suspended. The cafeterias and restaurants shall remain

closed to the public, and may exclusively provide services of home delivery.



Fifth.- Opening to the public of all commercial premises and establishments is suspended except for supermarkets, filling stations, pharmacies and those providing basic services.

Sixth.- Constraints on freedom of movement: while the State of Alarm remains in force, individuals may only use the public rights-of-way to perform the following activities:

- o Acquisition of foodstuffs, pharmaceutical products and other basic needs.
- o Attendance at healthcare centres.
- o Displacement to the workplace to provide their occupational, professional or business service.
- o Return to the place of normal residence.
- Assistance to and care for senior citizens, minors, dependent persons, disabled persons and especially vulnerable persons.
- o Displacement to financial entities.
- o For reasons of force majeure or situations of need.
- o Any other analogous activity with due justification.

Seventh.- In the event of urgent need, you can contact the duty service 24 hours per day:

Eighth.- We request that you heed the indications of the Port security service, the public authorities, and in particular, the health authorities, at all times: this is for your own safety and everybody else's.

We hope to see you enjoying Puerto Banús anew in a few weeks.
